BULK CHEMICALS FOR WATER & WASTEWATER TREATMENT**

AGREEMENT ADDENDUM NO.1

THIS ADDENDUM entered into this 10th day of August, 2015, by and between **HARFORD COUNTY, MARYLAND**, a body corporate and politic of the State of Maryland, hereinafter called the "County", and **TILLEY CHEMICAL COMPANY, INC., 501 Chesapeake Park Plaza, Baltimore, Maryland 21220**, hereinafter called the "Contractor".

WHEREAS, on May 23, 2014, the County and the Contractor entered into an agreement to provide specific bulk chemicals ("Agreement") to Harford County, Maryland; and

WHEREAS, per Section VIII of the Agreement, the Contractor may submit a request for a price increase per contract year; and

WHEREAS, the Contractor has submitted a request dated June 12, 2105 for a price increase; and

NOW, THEREFORE, in consideration of the representations, covenants and promises and the recitals which are incorporated herein, the parties, intending to be legally bound, agree as follows:

1. The request of 3% increase for the price of Phosphoric Acid has been granted and will become effective for deliveries made on or after July 1, 2015 as follows:

Phosphoric Acid	\$1,300.00/wet ton	\$1,340.00/wet ton

2. Add new Section XIV as follows:

SECTION XIV: EXECUTION IN COUNTERPARTS

This Agreement and any modification thereto may be executed in one or more counterparts, and shall be deemed valid if delivered electronically (e.g., facsimile, PDF, ink or digital stamp, etc.), each of which will be considered an original instrument, but all of which will be considered one and the same Agreement, and will become binding when one or more counterparts have been signed by each of the Parties hereto and delivered to the other.

3. Except as specifically provided herein, the terms and conditions of the Agreement shall remain in full force and effect.
