Project CENTRAL MARYLAND REGIONAL TRANSIT PLAN PILOT CORRIDOR ANALYSIS CORRIDOR 25: BWI TO COLUMBIA TOWN CENTER 22T11

The Baltimore Metropolitan Council (BMC) provides written responses to questions regarding requests for proposals (RFPs). The following are questions and answers concerning the above-referenced RFP.

Q1. Under Task 2 of BMC's Scope of Work, there are several subtasks that mention providing sets of data to the consultant (Existing Transit Service, Commuter and Demographic Characteristics, and Land Use, Development and Zoning). Can you please clarify exactly what will be provided for these subtasks?

A1. Data will be provided or is available via open source as follows:

Existing Transit Service:

- *General Transit Feed Specification (GTFS) data, transit service schedules in and around the corridor.*

Commuter and Demographic Characteristics:

- *BRTB's latest adopted forecast includes population, households and employment forecasts for the 2015-2045 period, and is formatted by jurisdiction as well as Small Geographic Areas (94 regional planning districts (RPDs) and 1,392 transportation analysis zones (TAZs)).
