3. RECOMMENDED ACTION ON RESOLUTION #25- 1 (10 MIN)

The TC is asked to recommend sending Resolution #25-1 to the BRTB for approval. This resolution is a request from MDOT MTA to update funding for two projects: 1) Agencywide System Preservation and Improvement and 2) Metro and Light Rail System Preservation and Improvement.

The TC is asked to recommend sending Resolution #25-2 to the BRTB for approval. This resolution is a request from Baltimore County to update funding for two projects: 1) Torrey C. Brown Trail Safety Improvements and 2) Wise Avenue and Holabird Avenue Bicycle Facilities.
