MDOT MTA has submitted seven projects requiring an amendment of the TIP, these include: 1) Kirk Bus Facility, 2) Metro & Light Rail Rolling Stock, 3) Metro & Light Rail System Preservation, 4) Small Urban Transit, 5) Bus and Rail Preventive Maintenance, 6) Martin Airport All Stations Accessibility Program, and 7) Low Floor Light Rail Fleet Transition projects.
- 5. PRESENTATION: ELECTRIC VEHICLE (EV) COMMUNITY CHARGING HUBS FOR MULTI-UNIT DWELLINGS (20 min)**

Ms. Abby Morgan, PhD, Kittelson and Associates, will describe this activity. A key deliverable is a guide to help local jurisdictions understand how to plan community charging hubs to serve people who drive EVs and have barriers to charging their vehicles at home. The guide's Community Charging Hub Planning Toolbox explains how to engage with community stakeholders; select locations for charging hubs; plan for the design, operations, and maintenance of hubs; and support workforce development. Five accompanying fact sheets provide talking points on EVs and EV charging, Community Charging Hubs, Workforce Development, Preparing for Grants, and Statewide Incentives.
