## **MINUTES**

## 1. WELCOME AND INTRODUCTIONS

Officer Lori Hippensteel, Baltimore County Police Department (BCoPD), called the meeting to order at 10:00 A.M. She welcomed everyone to the meeting.

## 2. APPROVAL OF DECEMBER 2021 MINUTES

Ofc. Hippensteel, BCoPD, asked for any comments or changes to the minutes from the December 16, 2021 Baltimore Regional Safety Subcommittee meeting. Receiving none, the minutes were accepted into the record.

## 3. STATE SAFETY UPDATES

**MDOT MVA MHSO** - Ms. Myra Wieman, Deputy Director of the Maryland Department of Transportation (MDOT) Motor Vehicle Administration's (MVA) Highway Safety Office (MHSO), shared information about grant funding through that office.

Ms. Cynthia Spriggs, Pedestrian/Bicycle Program Manager at MHSO, shared information about proposed state legislation in the 2022 session.

Ms. Anna Levendusky, Communications Manager for MHSO, shared information from the zerodeathsmd.gov website. She noted the monthly social media toolkits and more features being added to the Resources page in the coming weeks.

**MDOT SHA** - Dr. Jay Zheng, MDOT State Highway Administration, provided an update of the Highway Safety Improvement Program (HSIP) local funding. He shared that the funding announcement was distributed in mid-February and the process has not changed much from the 2021 cycle.

## 5. LOCAL STRATEGIC HIGHWAY SAFETY PLANS (SHSP)

Ms. Eileen Singleton, BMC, provided an overview of the Traffic Incident Management for the Baltimore Region (TIMBR) committee. She explained its mission, activities, and updates to the Move Over Law legislation that are under consideration.

Ms. Cindy Burch, BMC, shared an update of the Local SHSPs in the region:

- Anne Arundel County's Vision Zero plan is out for public comment until March 1, 2022
- Baltimore City has developed a local plan and it is under final review
- Baltimore County continues to implement its SHSP
- Carroll County has finished the Strategic Traffic Safety Plan (STSP) and is scheduling time to present it to the County Commissioners
- Harford County is implementing the SHSP through the Traffic Safety Advisory Board
- Howard County is implementing a Strategic Road Safety Plan (SRSP) and will be sharing it with the county's Bicycle Advisory Group in April 2022
- Plans are being made to reconvene the Queen Anne's County SHSP team
