#### Overview of the 2026-2029 TIP


- 173 federally-funded and regionally significant projects
  - 9 are new projects
- \$6.2 billion in proposed federal, state, local, and toll funds
  - \$3.22 billion federal; \$1.085 billion state/local
  - Highway, transit, bicycle and pedestrian projects
  - Maintaining, operating and expanding the transportation system
- Projects support long-range transportation goals
  - For example: safety, prosperity and economic opportunities and environmental responsibilities
- Funding limited
  - Programmed funds cannot exceed what is reasonably expected to be available from local, state, and federal sources








# Funding in the 2026-2029 TIP by Agency

#### **Active Transportation Focused Projects**

#### 17 projects focused on active transportation facilities

- 1. Greenway Middle Branch Phase 2 (Baltimore City (BCi))
- 2. Vision Zero Action Plan and Pilot (BCi)
- 3. Northern Parkway at Falls Road Traffic Safety and Multimodal Facility Improvements (BCi)
- 4. Frederick Avenue ADA Upgrades (Brunswick to S. Smallwood) (BCi)
- 5. Belair Road Complete Streets (BCi)
- 6. West North Avenue Pedestrian Safety Improvements (BCi)
- 7. Baltimore Greenway Trails Network Eastern Segment (BCi)
- 8. Frederick Avenue Streetscape (Yale to Monastery) (BCi)

- 10. Baltimore Greenway Trails Network Northern Segments (BCi)

# **Projects Including Active Transportation**



I-695: Bridge Replacement on Putty Hill Avenue

State Highway Administration 2028

 Dozens of other highway and bridge projects include or consider active transportation facilities.

#### Some examples include:


- I-695: Bridge Replacement on Putty Hill: The new bridge will include 6' bicycle-compatible shoulders with 5'8" sidewalks on both sides of the bridge.
- Wilkens Avenue Bridge Over Gwynns Falls: The existing sidewalks will be replaced with standard SHA and ADA compliant sidewalks.
- MD 175: Sellner Road/Race Road to McCarron Court: Adding a shared-use path and bicycle compatible shoulders.





# **Air Quality Conformity**

- Ensures the projects in the 2026-2029 TIP do not make air quality worse or delay the attainment of national ambient air quality standards (NAAQS).
- Requires that transportation emissions do not exceed motor vehicle emission budgets (MVEBs) in the state air quality implementation plan (SIP).
- Ties together transportation planning and air quality planning.




#### **Quick Facts**

Over 3,896 views on the project website and over 379 views of the StoryMap



How satisfied are you with current transportation infrastructure (roads, bridges, transit) in your area?








#### **Public Comment Period: Most Heard Comments**

- Increase support for biking, walking and public transit.
- Improve road safety and reduce fatalities
- Address air quality with bold action to reduce car use.
- Reduce spending on highway and parking expansion.







#### **Calls for a Connected Network**

- "...I would like to see additional funding for planning of bicycle routes.
   The Baltimore Metropolitan Council recently released a "proposed regional bike network," which details several additional routes that need investment and should be funded within the next few years." [Public Comment: Anonymous]
- "I wish these things didn't take years to implement. It really kills the momentum. In my mind...paint down bike lanes everywhere so that we have a connected system to work with, then put in the more expensive infrastructure to make it permanent." [Public Comment: Brody]







# **Safety Benefits**

- "Please prioritize... and connecting on-street separated bike facilities with safer pedestrian facilities and crossings for vulnerable road users at intersections." [Public Comment: Daniel Paschall]
- "We must continue to support investments in bike and pedestrian infrastructure because they offer a wide range of benefits, including improved safety..." [Public Comment: Transit Choices]
- "We call on the BRTB to shift its spending priorities away from bigger roads and toward accessible sidewalks, crosswalks, bike paths, and high-quality public transit that helps increase access and safety for all." [Public Comment: CMTA]



# **Air Quality Improvements**


- "If the only way to get around the region is in a car the air quality will never be good. Regardless if they are electric or gas. Biking walking and transit expansion is the ONLY way." [Public Comment: David House]
- "Highway expansion hasn't helped anyone. If the city wants to commit to reducing pollution, it should focus on reducing car reliance and expanding alternate transport options." [Public Comment: Anonymous]
- "The only way to meet our air quality goals is higher transit frequency and more transportation options to get people out of cars." [Public Comment: Kamran]

# Reduce spending on highway and parking expansion

- Commentators see a shift towards more investment in active transportation and non-car modes, but room for improvement
  - "It's a relief to see money being spent on micromobility, the redline, and more non-car related infrastructure projects." [Public Comment: Kamran]
  - "Glad to see Penn Station area will get multimodal improvements, the station is not connected very well to the area." [Public Comment: Brody]
  - "Definitely improvement but need so much more. We really need more investment in transit, cycling and pedestrian infrastructure and less for highways." [Public Comment: Anonymous]
  - "There are a few much-needed projects for bike infrastructure in Baltimore, like the Greenway projects and Washington St, and it's good to see those included. However, there are also some significant items missing..." [Public Comment: Anonymous]
