### Overview of the Certification Process

#### The review consists of 3 primary activities:

- 1. A site visit including discussions with: MPO, MDOT, SHA, transit operators; and the general public.
- 2. A report prepared by FHWA/FTA summarizing review findings and certification action.
- 3. A closeout presentation of the review at a future MPO Policy Board Meeting.



# What Is Next and What Are Possible Outcomes of This Review?

- Report issued within 60 days summarizing the discussions during the review.
- Process is certified; certified subject to certain corrective actions; certified for use of only certain construction funding categories; or
- Process is not certified; Withhold Funds; or Withhold approval of all or certain categories of projects.



# Metropolitan Transportation Planning

#### Why is the process important?

- Establishes a mechanism for collaboration,
- Provides the framework for the future transportation system, and
- Due to limited funding, the MPO must prioritize the regional needs and determine the best and most economical solution.

#### How is process carried out?

- Through a"3-C" approach
  - Continuing
  - Cooperative
  - Comprehensive
- With public agencies, not-for-profits, citizen and community groups and others.



#### **Certification Review Elements**

- A Certification review occurs every 4 years
- Ensures that all federal mandates are met
- Not all possible topics are covered to same extent or in same manner

#### Our Federal Partners look to ensure that:

- The planning process addresses major issues facing the region
- To identify noteworthy practices and opportunities and that there is continued progress from prior reviews
- All planning partners appropriately cooperate in the planning process
- Products and process are compliant with federal regulations
- Stewardship of planning process
