- **Two-Year Funding Cycle**
- **Two Types of Funding**
 - Capital (80/20 match)
 - Operating (50/50 match)
- **Two Review Processes**
 - Rural or Small Urban
 - BRTB - Endorse/Not Endorse
 - SCCHST – Approve/Amend/Deny
 - Large Urban
 - BRTB – Approve/Amend/Deny

Section 5310 Program: Criteria



- **Extent and Urgency of Local Needs (10 points)**
- **Coordination and Cooperation (20 points)**
- **Vehicle Utilization (10 points)**
- **Fiscal and Managerial Capability (10 points)**
