2023-2026 TIP Amendment Overview

- This amendment will add a new project to the FY 2023-2026 TIP.
 - 2017-2020 TIP utilizing FHWA Federal Lands Access Program (FLAP) funds and was funded for feasibility study only.
- MPA is in the planning phases of designing and constructing a shared use path along Frankfurst Avenue in Baltimore, City. The path is expected to span between Masonville Cove, the Nation's first Urban Wildlife Refuge Partnership, and Hanover Street.





Amendment Purpose


- The Maryland Port Administration was awarded a Federal Land Access Program (FLAP) grant to design and construct a shared use path named the Masonville Cove Connector.
- As a Transportation Improvement Program (TIP)
 requirement, the Masonville Cove Connector under FLAP,
 will require a TIP amendment as the project moves from the
 conceptual phase into the implementation phase.
- As a reimbursable funding mechanism, FLAP will include the costs of Project Planning, National Environmental Protection Act (NEPA), Right-of-Way, Construction and other project costs.





Project Limits

Eastbound and Westbound along Frankfurst Avenue, beginning at South Hanover Street and ending at the Masonville Cove Environmental Education Center, a distance of 3,800 feet.

- Establish safe, convenient, and equitable access to Masonville Cove Environmental Education Center
- Connect local communities to a unique recreational asset
- Connect Masonville Cove to other trails and to recreational areas throughout Baltimore City

- 30% Design Complete- Fall 2023
- 100% Design Complete- Fall 2024
- Construction Complete Fall 2025
