


Anne Arundel County Ferry Project

Scope: New Passenger Ferry Service connecting Annapolis, Baltimore and Queen Anne's County (Matapeake). Includes electric ferry purchase, landing improvements and charging infrastructure.













Cost

- Up to two (2) Passenger Electric Ferry Vessels
 - Local funds \$879,750 Federal funds \$3,519,000
 - Total \$ 4,398,750
- Landing Improvements
 - Local funds \$50,000 Federal funds \$200,000
 - Total \$ 250,000
- Charging Infrastructure
 - Local funds \$44,000 Federal funds \$176,000
 - Total \$ 220,000

Rural Capital Assistance



Background

- This was a previous project in the past TIP that we are adding to the current TIP.
- This request supports preventive maintenance in Carroll County and a Baltimore County project for four medium duty buses.

Benefit

This funding assists rural transit systems with capital funding.

Apportionment

 This amendment will add approximately \$4M in 5311 funds and approximately \$1M in local and state match.

Schedule

Ongoing work.





Urban Capital Assistance



Background

 Harford County was awarded a FY 2021 Bus and Bus Facilities grant for vehicle purchases. The expected obligation year is FY 2025.

Benefit

This funding assists urban transit systems with capital funding.

Apportionment

 This amendment will add approximately \$1.4M in 5311 funds and approximately \$265k in match.

Schedule

Ongoing work.

Annapolis Electric Ferry Pilot Program



Introduction

- The amendment is to move \$3.5M for the Battery Electric Ferry project to FY 2025, the anticipated year of obligation
 - Federal \$2,975,000
 - Local \$525,000
- The National Environmental Policy Act (NEPA) review completed (July 2024)



Ferry Service Overview

- A new fixed route ferry service for passengers and bicycles
- Proposed route is about one half mile long, connecting Eastport to Downtown
- Will complement existing on-demand water taxi service
- Estimated annual ridership: 20,500



Program Cost/Funding

- Total program cost: \$3.5M (capital only)
- Funding Sources
 - Federal: Section 5307 Passenger Ferry Grant Discretionary Program
 - Local matching funds
- Financing Ratio
 - Federal: 85% (\$2,975,000)
 - Local: 15% (\$525,000)



Program Components/Cost

- Ferry Vessels (2): \$1,800,000
- Landing Improvements: \$1,500,000
- Charging Infrastructure: \$200,000



Program Timeline

- The City of Annapolis is about to award a contract for Ferry Vessels with integrated charger.
- RFP for landing improvements will be released in March 2025.
- Ferry service is anticipated to begin in FY 2026.
