What is the Master Establishment File?

 A point-level spatial inventory of businesses and organizations operating in the Baltimore region

How is it developed?

- Uses the point-level QCEW file as a base
- Geocoded by BMC staff
- Reviewed / edited by local jurisdictions
- Returned to BMC edited files reintegrated to form MEF





What is the MEF Used for?

- Assists with Employment Allocation
- Development of model inputs





- How to get started Logistics
 - Confidentiality Agreement
 - QCEW File contains confidential information
 - Users must review, understand, and sign the agreement
 - File Transfer
 - QCEW file is located on a password protected FTP site
 - After BMC receipt of signed confidentiality agreement, staff will contact CFG members individually to supply access to the file





- QCEW Review/File Cleaning Focus Areas
 - Government Records
 - Example: Fire and Police
 - Public Schools
 - Employment allocated to each school
 - Large Employers (100+ Employees)
 - Verify presence, location, employment
 - Whatever else you can do
 - As resources permit
