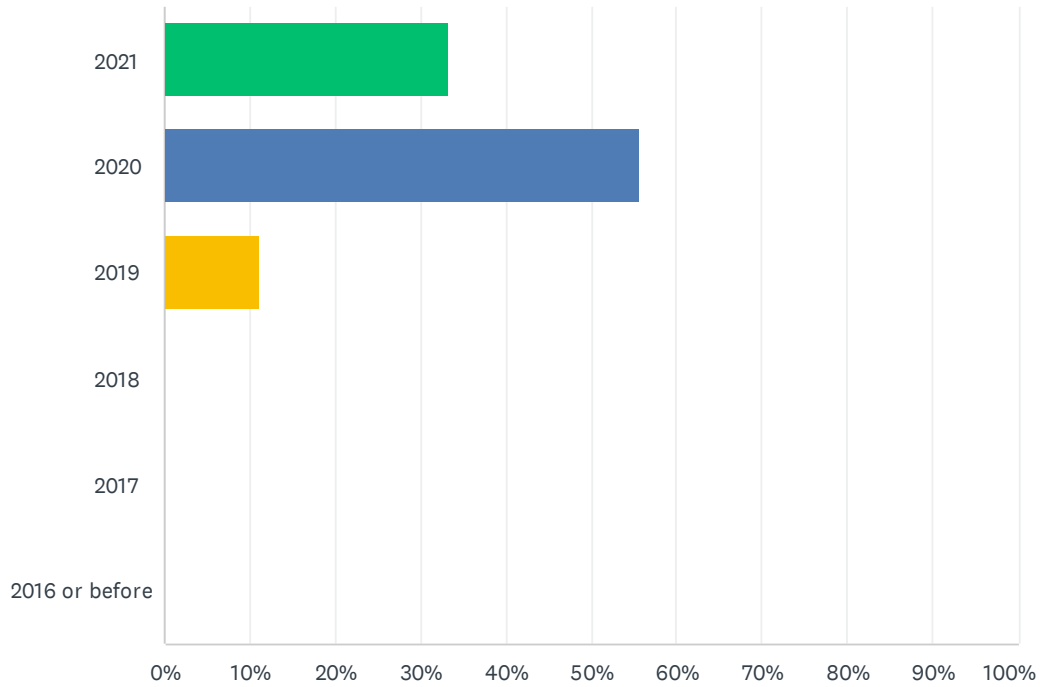


## Q1 When did you ask to port your voucher?

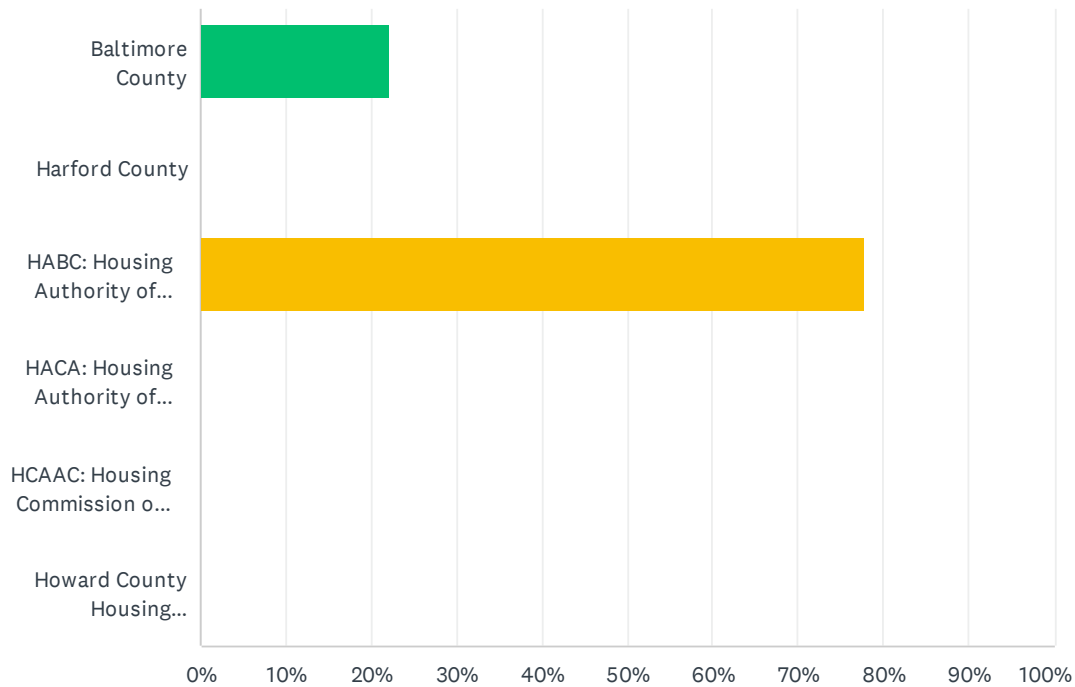

## Q2 Which agency did you try to port FROM?

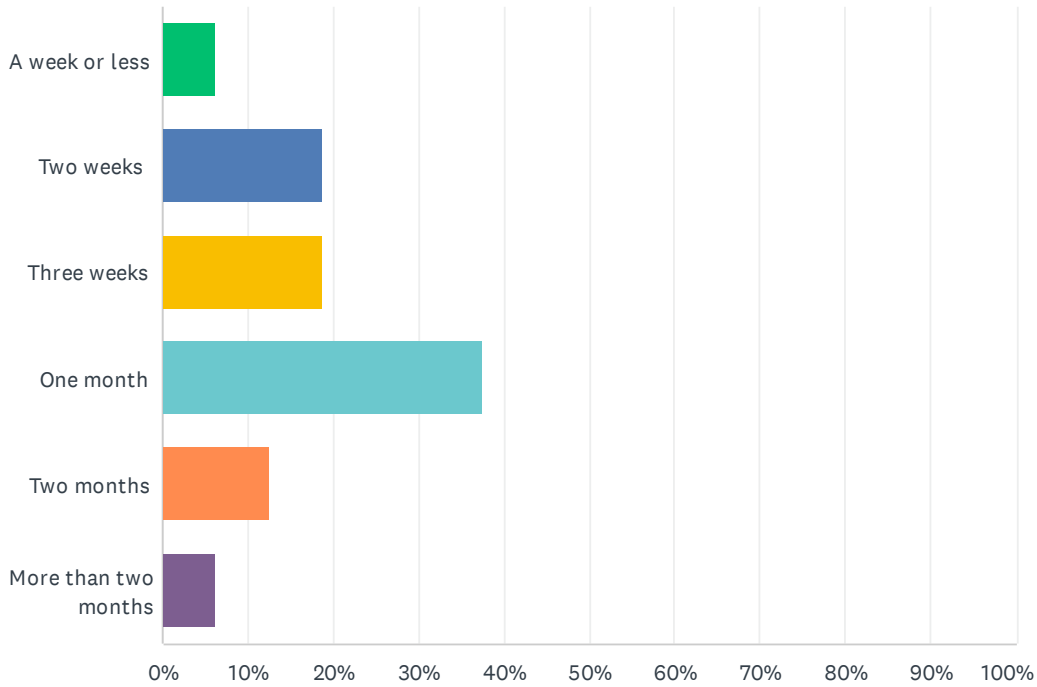

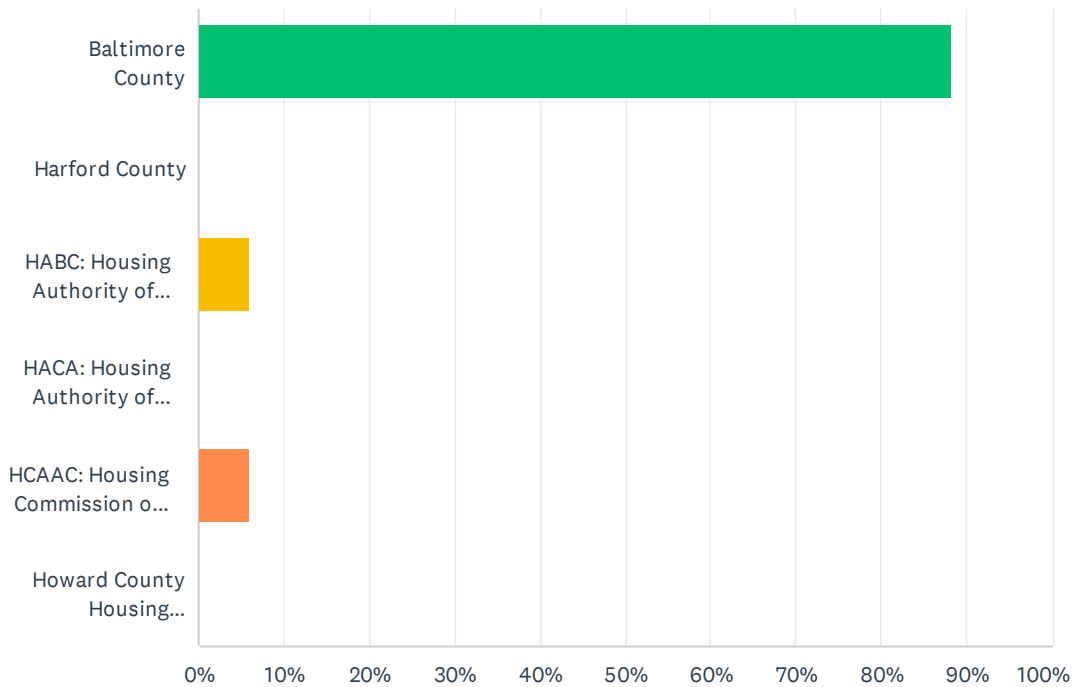

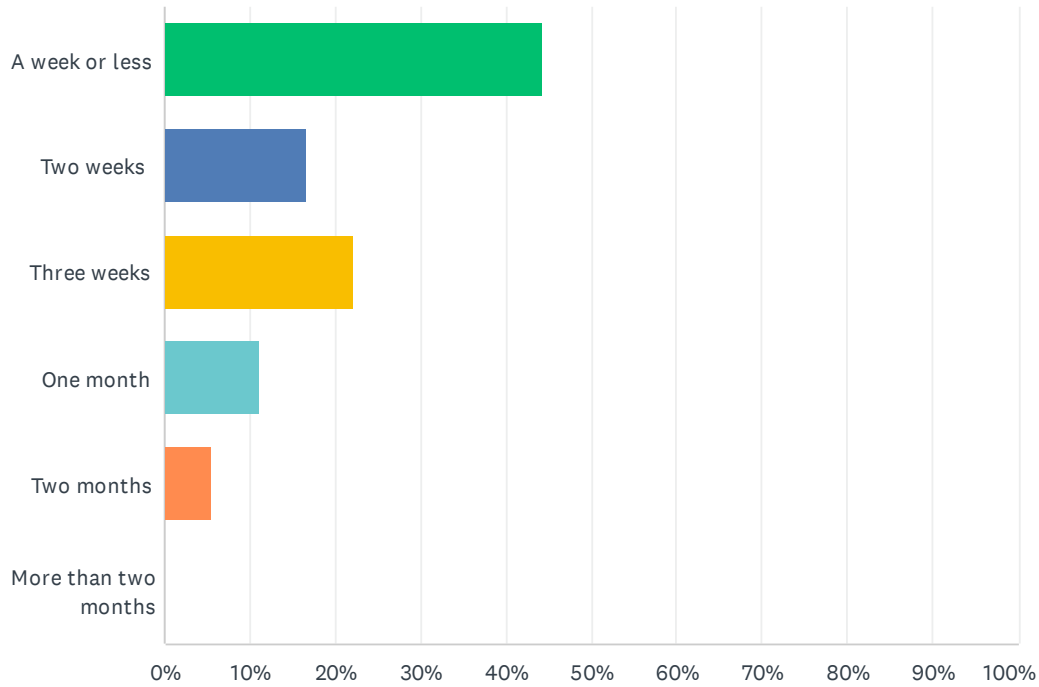

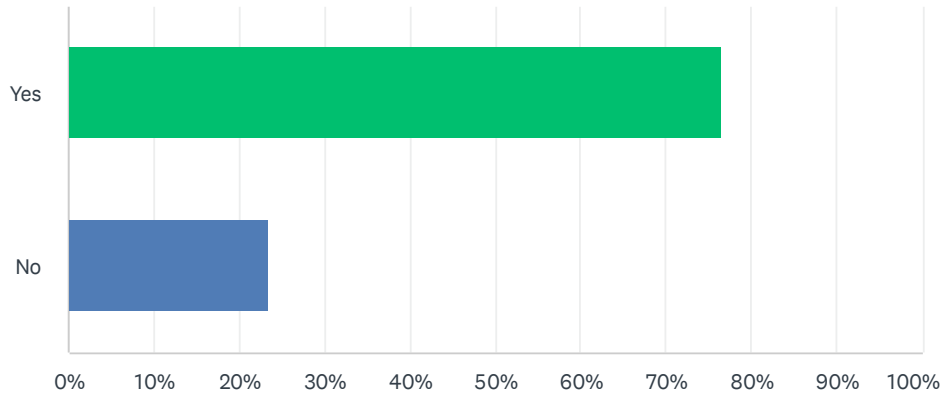

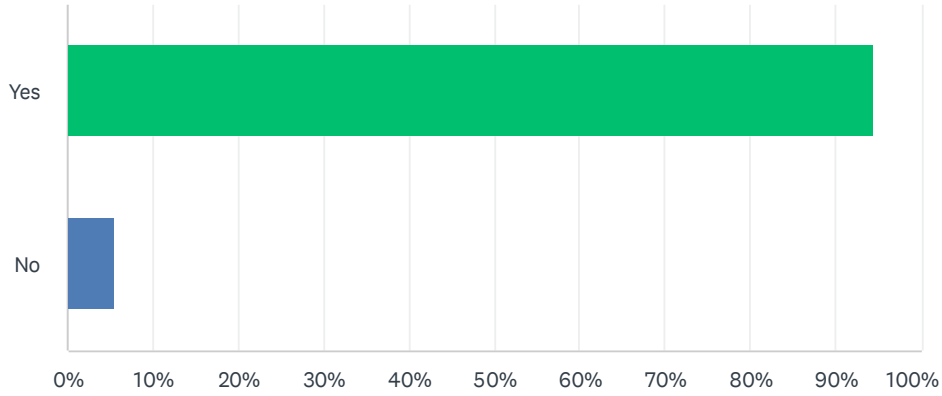

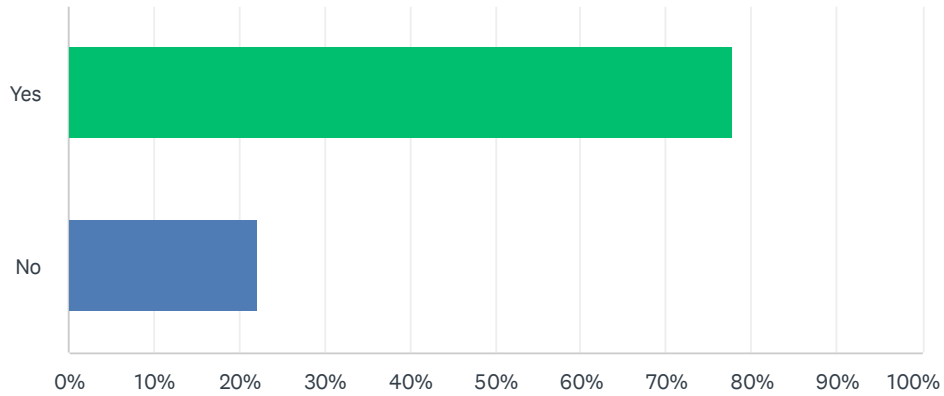

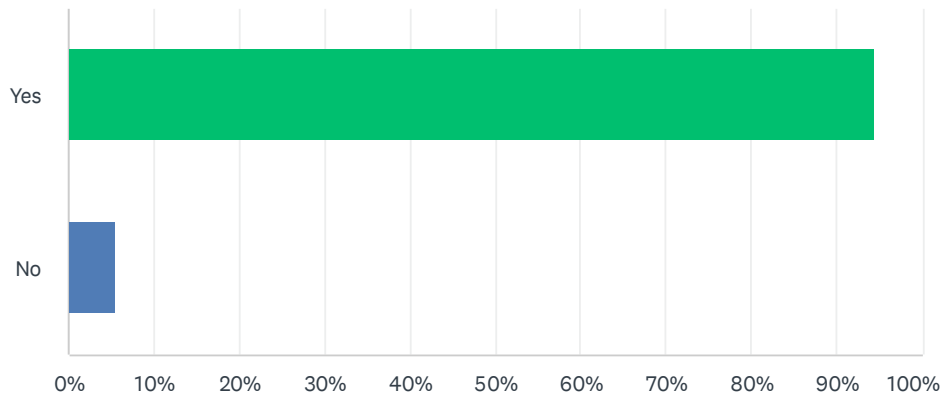

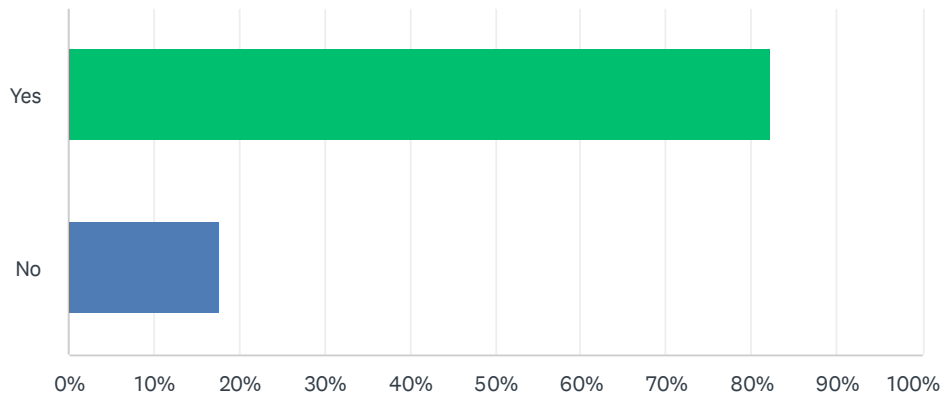

## Q10 Did you end up moving into a home you had already identified?

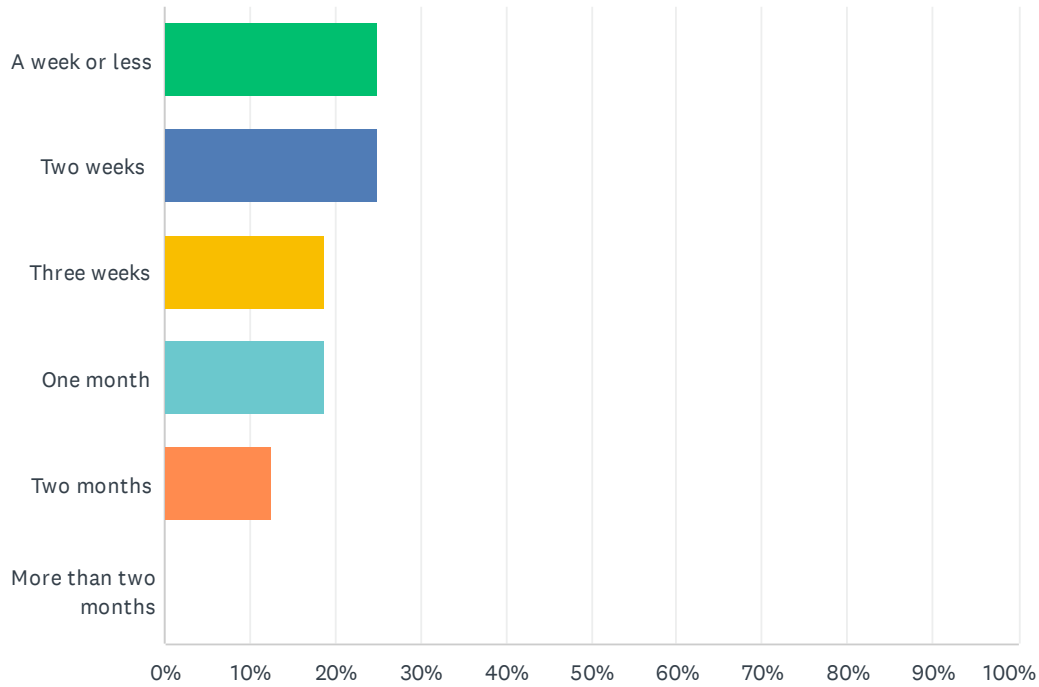

## Q11 How long did you wait for an inspection of your new home after you turned in your Request for Tenancy Approval?

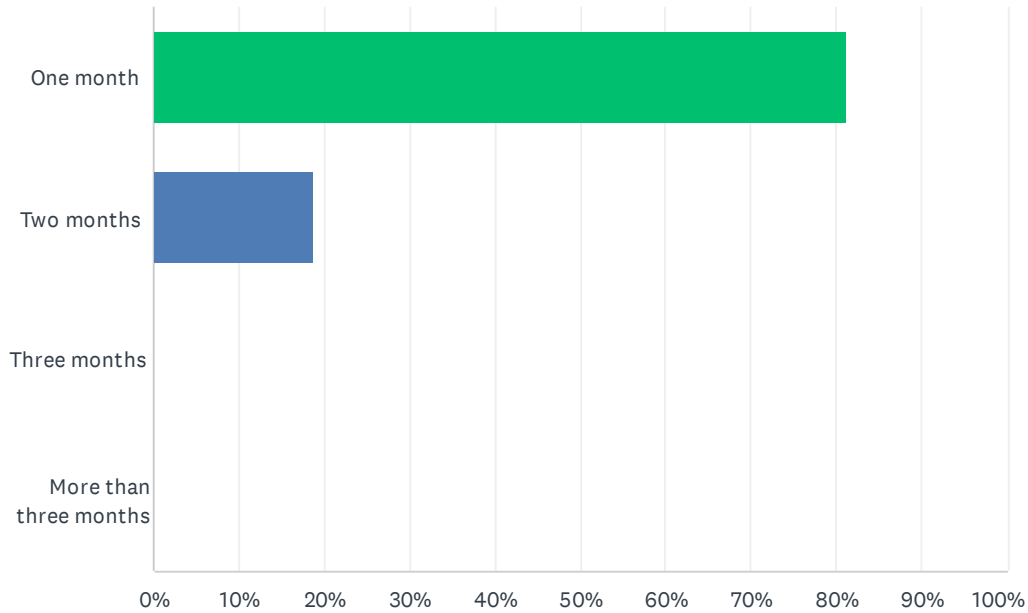

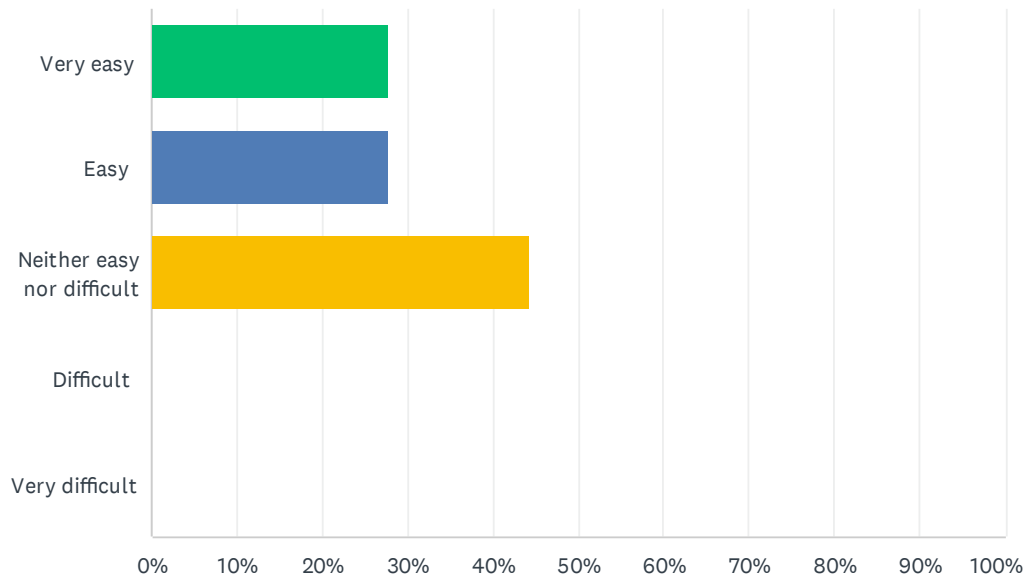

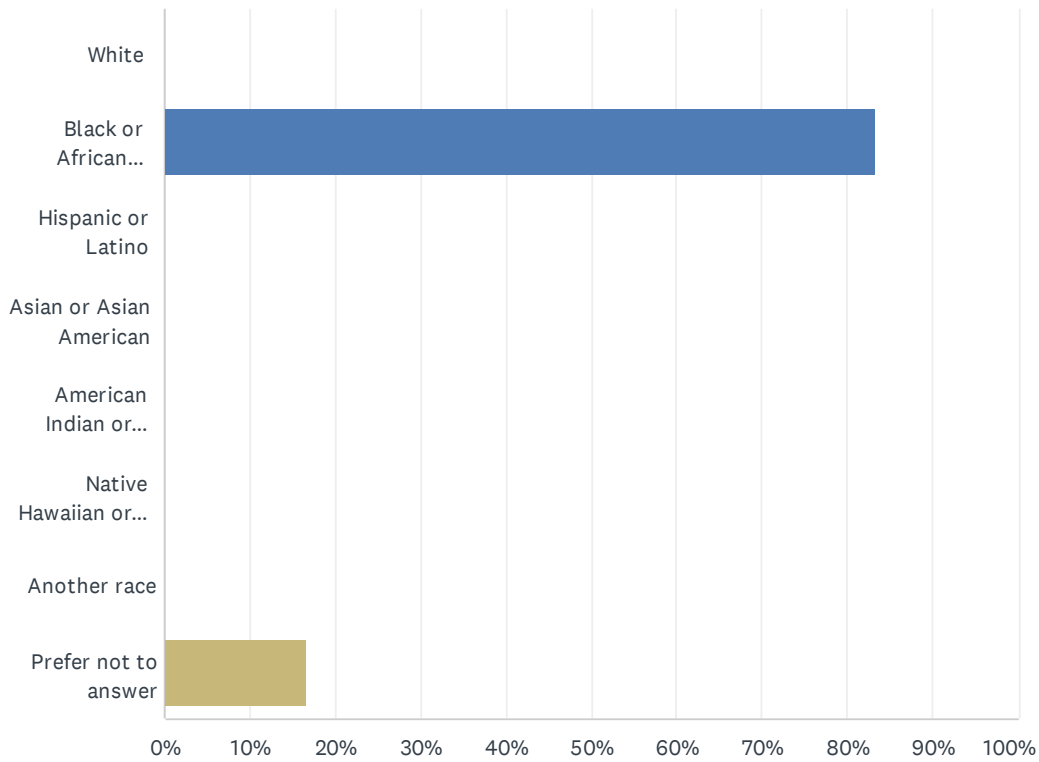
