Charging and Fueling Infrastructure (CFI) Discretionary Grant Program

- Announced in January 2024 by U.S. Department of Transportation (USDOT), Federal Highway Administration's (FHWA)
- Made possible by the Bipartisan Infrastructure Law
- Will fund 47 EV charging and alternative-fueling infrastructure projects in 22 states and Puerto Rico
- Complements the \$5 billion National Electric Vehicle Infrastructure (NEVI) formula program to build the “backbone” of high-speed EV chargers along the nation's highways

Awarded \$15M for COMMUNITY projects

Maryland Equitable Charging Infrastructure Partnership (MECIP)



- The Partnership is made up of statewide public and private partners working collaboratively to bring ready-to-deploy equitable charging and infrastructure to the State of Maryland.
 - 6 private companies
 - 3 Counties
 - 2 Cities
 - UMD
 - IBEW Local 24

MECIP CFI – Project Purpose and Need

The Goals of the CFI Program are to:

- **Supplement**, not supplant, necessary private sector investment—MECIP will bring \$9,692,283 in private sector investment.
- **Complement** existing Federal programs—MECIP, working with MDOT and their NEVI plan goals.
- **Facilitate** broad public access to a national charging system and to accelerate adoption of zero emissions vehicles
- **Accelerate** vehicle adoption of zero emissions vehicles through partnerships with vehicle dealerships, community outreach, and by bringing additional vehicle chargers to every region of the state.

MECIP CFI – Project Purpose and Need

- **Implement** Justice40 objectives—MECIP impacts Justice40 areas throughout the state, as well as Low-to-Moderate Income (LMI) areas in rural and urban Maryland.
- **Reduce** greenhouse gas and vehicle-related emissions

MECIP CFI – Community Program Outcomes

- **Construction**

- 58 sites throughout Maryland

- **Workforce Development**

- Maryland's IBEW Local 24 will advance job quality by providing EVITP Training and Certification to 300 current IBEW Journeypersons.
- Provide 300 apprentices with the opportunity to become certified in EVITP
- Registered Apprenticeship program will also provide direct workforce development in the EV installation field to disadvantaged community members

- **Tracking and Measuring – UMD Build America Center**

Reducing:

- Fuel use by 9,119.6 barrels annually
- Greenhouse gas (GHGs) emissions by 2,894.6 metric tons annually
- Other pollutants CO, NOx, PM10, PM2.5, VOC, and Sox by 44,121.4 lb. annually
