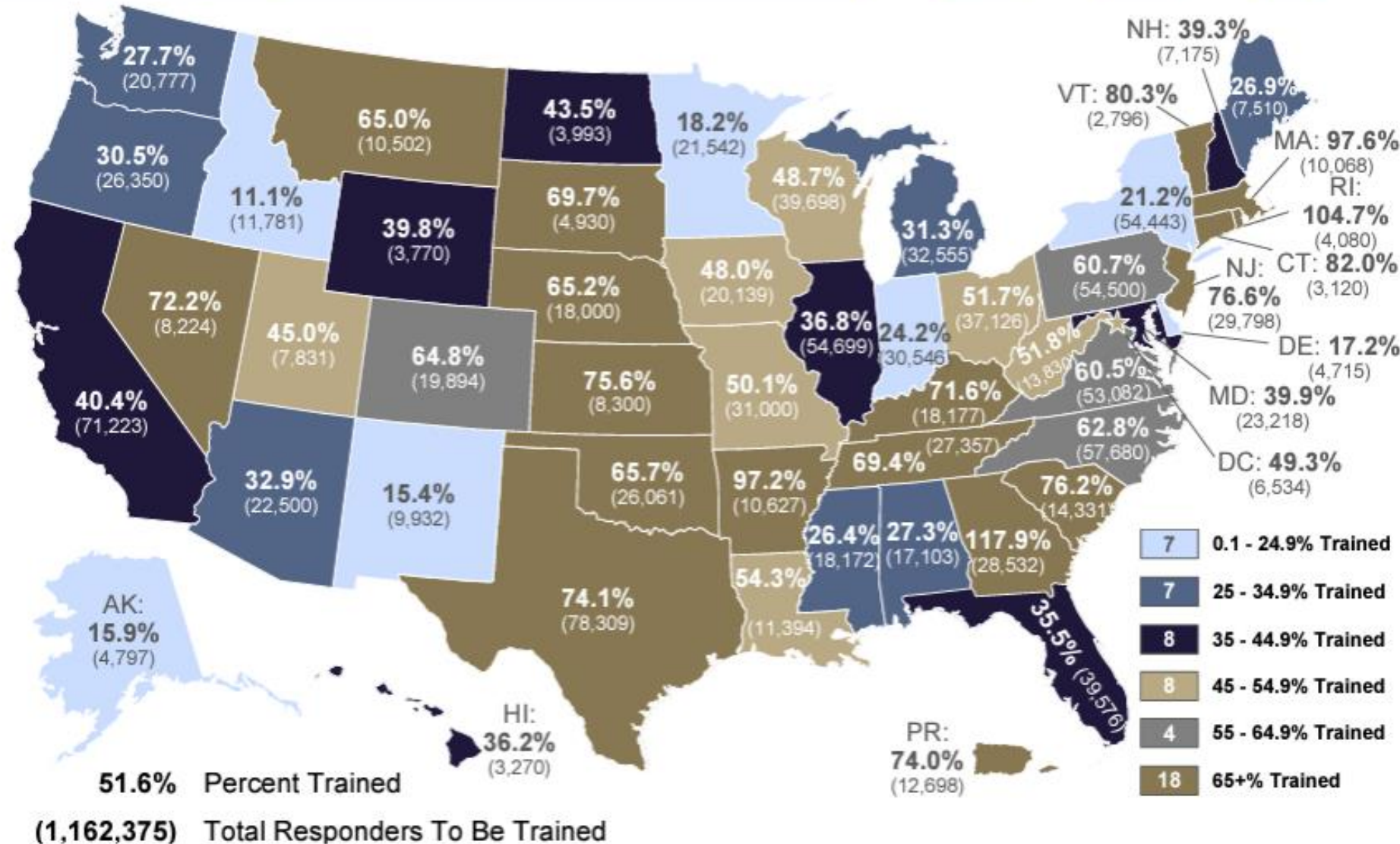
TIM Training Program Implementation Progress Percent Trained – Goal of 55% - As of August 29, 2022
