This is a Unit Price and Catalog Contract for General Materials of Instruction.

Wicomico County Public Schools served as the Lead Agent for this Mid-Atlantic Purchasing Team (MAPT) procurement. MAPT is the cooperative efforts of the members of the Baltimore Metro Council (BRCPC) and Metropolitan Washington Council of Governments (MW COG).

Historically, WCPS' MOI contract has been "piggy-backed" by the nine Eastern Shore of Maryland County Public Schools. The MAPT contract is a regional contract designed to serve Maryland, and the Washington D.C. area, including the adjacent Virginia schools.

The Contract documents allowed for award "In Total" to one responsive and responsible bidder.

Evaluation is net cost of the "Market Basket" and the "percentage discount from list" offered for all other items in published catalogs.

"Market Basket" - Evaluation Criteria:
