Section 15.01 CHIEF OPERATING OFFICER Colossal Contractors, Inc. and Tito Contractors, Inc. Gymnasium Renovation and Repair Services

Request of the Board

The Chief Operating Officer requests the Board's approval of a competitively solicited contract with Colossal Contractors, Inc. and Tito Contractors, Inc. to provide gymnasium renovation and repair services. The estimated total contract amount is \$5,000,000.00. The contract term is July 29, 2020 through July 28, 2023 with one (1), two-year renewal option.

The estimated cost for an individual service ranges from \$500.00 to \$150,000.00. New high school gym floors can cost up to \$150,000.00 for replacement. The rates are fixed for the term of the agreement including the renewal years. Work and services to be provided at time of need.

Work may include upgrades and/or installation of social distancing and safe practice accessories as identified per received guidance.

Solicitation process: Pursuant to Section 3-101(2) of the Procurement Administrative

Regulations, on March 11, 2020 City Schools issued a competitive sealed bid: IFB-20029. On April 16, 2020 three (3) bid responses were received with Colossal Contractors, Inc. and Tito contractors, Inc. deemed the low responsive and responsible bidders. One response

was deemed not MBE compliant.

MBE/WBE Results: The MBE/WBE goals for this solicitation are 27% MBE and 10% WBE,

in accordance with City Schools' guidelines. Colossal Contractors, Inc. and Tito Contractors, Inc. agreed to meet the 37% goal with 27% African-American and 10% Women. Tito Contractors, Inc. is an MBE. City Schools MBE/WBE Liaison has reviewed and approved contractor's compliance with the stated MBE sub-contracting goals.

Financial/Budget Implications

School Operations has financial means through yearly budget allocation to support gymnasium renovation and repairs identified and directed to perform. For the replacement of gym floors, funds are provided through external partners (Under Armour) and State Supplemental Allocated (SA) funds such as Aging School Project (ASP) funds.

Evidence of Effectiveness

Colossal Contractors, Inc. is currently the approved vendor for gymnasium repair and renovation services. Tito Contractors, Inc. has various contracts with City Schools and is performing similar work throughout the District. This contract would allow Facility Operations to continue to provide renovations and repairs to school gymnasiums that are identified.
