1. Catalog Discount Program for Public Works type items, such as EPA Parts Catalog **No discussion**
2. Uniforms Solicitation – State of MD, Calvin Gladden, Lead Buyer **Reported discussion from BRCPC meeting. Note next meeting of BRCPC members are to bring back their uniform requirements and commitment for a cooperative bid lead by the State of MD.**
3. Goals and Objectives for this Committee **Increase attendance and Mike Myers recommended identifying at least 3 procurements for this year. Group decided to meet again in April rather than quarterly.**
4. Cooperative Contract Forecasting Discussion:
 - a. Stephanie Whalen reported:
 - i. Various Hardware Supplies – A new price agreement will be in place prior to expiration
 - ii. Tree Trimming and Removal – A bid will be going out this Spring, we are not currently interested in a cooperative bid
 - iii. Household Hazardous Waste Disposal – Will be handled by our Waste Management contractor (Previously piggybacked Baltimore County) *Plan to use Md Environmental Service in the future.*
 - iv. Bio solids and Water Treatment Residual Management – **Looking for a Piggyback.**
 - v. Mapping Services – Ongoing agreement so we will likely enter into a new contract with them
 - vi. Open-End Contract for Flooring – Utilizing a Sourcewell Agreement (Did the same previously)
 - b. Mike Myers reported:
 - i. Snow plow blades will be rebid and include both steel and rubber. AACO is a current participant.
 - ii. Guardrails will be rebid and already includes participation from AACO and Charles C.
 - iii. Road Salt will be rebid
 - iv. Diesel Fuel is an excellent candidate for a cooperative procurement. MWCOG has a bid being release and AACO and CC are interested in participating.
 - c. Mike Decker reported: No cooperative opportunities available at the time.
